Ms. Tynan reported that the Friends of the Library ("FOL"):

- Discussed coordinating with the Town Crew to help with the landscaping.

LIBRARY DIRECTOR'S REPORTS AND FINANCIAL REPORT

Ms. Ouellette reviewed in detail the March 2024 Library Director's Report including the Expenditure Report.

Ms. Ouellette discussed:

- All is looking good with the balances.
- Duct cleaning was done.
- Few programs had been canceled. The eclipse program was doubled booked.
- Book club is doing great.
- Shamrock search was fun, with good participation.
- Childrens room doing great with fun new programs for the kids.
- The egg coloring was done.
- Janet and Bill Tynan will be honored with a Public Service Award by the Exchange Club on April 22nd at the Aqua Turf.
- Passports to Libraries Program began and runs till April 30th, great participation already, 150 libraries in the state are participating.
- Eclipse glasses were distributed for the people who pre-registered.
- Staff members completed their two-hour Sexual Harassment Training Program.

COMMITTEE REPORTS:

- **Finance and Budget:** Mayor Dunn cut the wages increase by 50% from \$50,049 to \$25,049. Eliminates the part time position for the Childrens Room and the wage increase for the staff will have to be redone.
